III. **Application Form:** The candidates are also required to bring a copy of their online application form.

IV. **Demand Draft of Fee to be deposited at the time of counseling:**

- (1) Rs. 31130/- for male candidates and Rs. 24130/- for persons with disability and women candidates of Haryana admitted in LUVAS.
- (2) Rs. 71130/- for the candidates of GNCT Delhi, admitted in LUVAS.
- (3) Rs. 11000/- Counselling cum registration fee including examination fee to be deposited at the time of counselling at LUVAS, Hisar by the candidates admitted against State Quota seats of private affiliated institutions.
 - The payments will be accepted in the form of demand draft in favour of **Director, Institute of Para Veterinary Sciences, LUVAS, Hisar** payable at any scheduled bank at Hisar.
 - The candidates admitted in the affiliated institutes/colleges against State Quota seats will have to deposit the tuition fee and other dues as applicable within two days at the concerned institute/college, otherwise the seat will be declared as vacant. The candidates admitted to the Management Quota seats will pay all dues to the concerned institute. The details of fee of State Quota as well as Management Quota seats may be enquired from the concerned institutes before attending the counselling.

- V. The candidates belonging to BCA/BCB categories have to submit latest income certificate at the time of counselling otherwise their candidature for admission will not be considered.
- VI. **The children of persons of Backward Classes having gross annual income of up to three lakh rupees shall first of all get the benefit of reservation in admissions. The left out quota shall go to that class of Backward Classes of citizens who earn more than three lakh rupees but up to six lakh rupees per annum. The sections of the Backward Classes earning above six lakh rupees per annum shall be considered as creamy layer.**
