**Note : Read following instructions carefully:**

- (i) The selected candidates are advised to download their provisional seat allotment letter from candidate login and bring one hard copy for reporting.
- (ii) The selected candidates have to report for document checking and other admission formalities on **04.09.2023 at 9:30 am** in the Veterinary Auditorium, COVS, LUVAS, Hisar and shall have to pay fees and other charges there and then, otherwise the seat will be declared vacant.
- (iii) All the above mentioned candidates are required to bring all the original documents, two recently taken photos and two sets of self-attested photocopies of documents etc. as per rule 3.11 of chapter-IV of the Prospectus, at the time of document checking, failing which he/she shall be refused for admission.
- (iv) Once, a candidate is allotted a seat in a college and the candidate fails to deposit the fee and complete other admission formalities, he/she will be debarred for subsequent counselling(s). However, such candidates may participate in Mop-Up counselling (if any).
- (v) The candidates claiming reservation under BCA/BCB categories are required to submit category certificate along-with latest Income Certificate issued on or after 01.04.2023 by the competent authority at the time of document checking, otherwise their candidature for admission will not be considered.
- (vi) The candidates may deposit the fees in the form of Demand Draft in favour of "Dean, College of Veterinary Sciences, LUVAS, Hisar" payable at any scheduled bank at

Hisar or through RTGS/NEFT and the proof of deposition of fees is to be submitted in the o/o Dean, COVS on 04.09.2023.

**Note:**

- (i) The fee and dues for PwD candidates of either gender will be the same as that for girl candidates as mentioned above.
- (ii) The facility of hostel is not available for the female students. Therefore, the female candidates are advised not to pay hostel fee along with the admission fees as mentioned above.
- (iii) The candidates are advised to visit the University website before reporting for document checking/fees submission/registration.
- (iv) The following fee/funds will not be charged from the students of Scheduled Castes category (only those who are eligible for Post Metric Scholarship) at the time of admission in B.V.Sc.&A.H. programme of College of Veterinary Sciences, LUVAS:

However, the eligible SC category students will pay the security and remaining charges at the time of admission.
