**Note:**

- a. If, any seat in reserved categories remains vacant after counselling scheduled on 13.12.2023 due to non-availability of candidates in that category then the seat will be converted as per rules mentioned in the Diploma Prospectus 2023-24 and will be filled on the same day **i.e. on 13.12.2023** by upgradation of already admitted candidates and from those candidates who have not been allotted seat so far.
- b. All the candidates who have taken admission in any college and given consent of upgradation, and those who have not been allotted seat so far are required to be present physically in **3<sup>rd</sup> counselling scheduled on 13.12.2023 for upgradation/allotment**. Upgradation/allotment will be done according to the merit and preferences filled by the candidate in the application form.
- c. If, still any seat in reserved categories remain vacant, those seats will be filled on the basis of combined merit list in Mop-Up counselling.

**(iv). MOP-UP (Physical) Counselling (if any): TO BE ANNOUNCED LATER.**

**No Sliding will be allowed in Mop-Up Counseling.**

**(Important: The candidates reporting late may lose their right of admission)**

***Important Instructions:***

- (i) The seats in online counselling **except Mop-Up Counselling** will be allotted strictly as per preference(s) given by the candidate in application form.
- (ii) The candidate, who has been allotted seat as per merit list in the respective category, is to report for document checking, fee deposition and other admission formalities as per the counselling schedule, **failing which his/her candidature will be cancelled and he/she will not be considered in the subsequent online counselling(s) even if he/she is higher in merit.** No separate letter in this connection shall be issued.
- (iii) The candidates are required to bring all the original documents, two recently taken photos and two sets of self-attested photocopies of documents etc. as per rule 3.13 of chapter-III of the Diploma Prospectus 2023-24, at the time of document checking, failing which they shall be refused admission.
- (iv) Once, a candidate is allotted a seat in a college as per his/her merit and preference filled in application form and the candidate fails to deposit the fee and complete other admission formalities, his/her candidature will be cancelled and he/she will be debarred from subsequent online counselling(s) even if he/she is higher in merit. However, such candidates may participate in Mop-Up counselling.
- (v) If a candidate is allotted seat in any online counselling, he/she has to give his/her consent in writing at the time of documents checking, whether he/she wants to participate in subsequent online counselling (s) or not. If he/she gives his/her consent not to participate in subsequent online counselling then his/her seat will be freezed in the college/institute where admitted.
- (vi) The candidates who have already been admitted are allowed for sliding from one college to another or within college from Management quota seat to State quota seat and vice-versa, based on their merit and preference(s) given in the application form, in the subsequent online Counselling(s) provided they had given their consent in writing for participation in subsequent counselling. If the college/seat quota of admitted



candidate is changed in the next counselling as per his/her preference then he/she has to report for that counselling in person, along with the original fee receipt of the admitted college of previous counselling, for confirmation of his/her upgradation. The fee already deposited by such candidate will be adjusted in the fee of allotted college. However, the candidate has to pay the difference of fee, if any, on the same day. **If such upgraded candidate does not report in person, then his/her admission will be cancelled and he/she will be debarred from subsequent online counselling(s).** However, such candidate can participate in Mop-Up counselling and has to deposit fees again, if admitted and his/her previously deposited fee will be refunded as per Refund Policy given in Diploma Prospectus 2023-24.

- (vii) If the additional seats of IPVS remains vacant after the 2<sup>nd</sup> online counselling due to non-availability of the candidate then these seats will be filled up in 3<sup>rd</sup> online counselling by converting the same as per rules mentioned in the Diploma Prospectus 2023-24.
- (viii) Any candidate who has taken admission in IPVS, LUVAS, Hisar or any affiliated private college/institute under any category will not be allowed in Mop-Up Counselling. If a candidate wants to cancel his/her admission for participation in Mop-Up counselling, he/she has to submit a request in the o/o Director, IPVS, LUVAS, Hisar, at least 2 working days prior to Mop-Up counselling, failing which he/she will not be allowed to participate in Mop-Up counselling. Such candidate has to deposit fees again, if admitted, and his/her previously deposited fee will be refunded as per Refund Policy given in Diploma Prospectus 2023-24.
- (ix) The candidates have to deposit their fee in the form of Demand Draft in favour of Director, IPVS, LUVAS, Hisar payable at any scheduled bank at Hisar.

Note:

- (i) "The Following fee/funds will not be charged from the students of Scheduled Castes category (only those who are eligible for Post Metric Scholarship) at the time of admission in VLDD programme of IPVS, LUVAS:

- i. University Admission Fee
- ii. College Development Fund
- iii. College Admission Fee
- iv. Examination Fee
- v. Laboratory Fee
- vi. Tuition Fee
- vii. Amalgamated Fund

However, the eligible SC category students will pay the security and remaining charges at the time of admission. The students fulfilling the conditions prescribed by the State Government for Post Metric Scholarship (PMS) are required to submit the following documents at the time of admission in VLDD programme.


- i. Haryana Domicile Certificate
- ii. Latest Income Certificate upto 2.5 Lakhs per annum
- iii. Aadhar Card
- iv. SC Certificate
- v. Undertaking (Annexure-XXII) regarding deposition of fee/funds as mentioned above within 15 days of getting post matric scholarship in their account."



**Fees and dues at the time of admission for SC students who are eligible for Post Metric Scholarship is: Boys and Girls- Rs. 3470/-**

- (ii) Any other charges, if applicable and approved by the competent authority will be chargeable at the time of admission.
- (x) The counselling schedule as mentioned above may revise. Therefore, all the candidates are advised to visit the university website regularly to get themselves updated with any change(s) in counselling schedule.
