Note:- The vacant seats of VCI quota, if any, will be converted in to State Quota as per rules mentioned in the Prospectus and same will be displayed on the day of counselling i.e. 15.11.2023.

Important Instructions:

- The number of vacant seats may increase and the final number of vacant seats will be announced on 15.11.2023 before start of counselling.
- No sliding will be allowed in Mop-Up (Physical) counselling scheduled on 15.11.2023.**
- All the eligible candidates who have applied at LUVAS for admission to B.V.Sc.&A.H. programme in COVS, LUVAS, Hisar and Affiliated Private Colleges, can participate in the Mop-Up (Physical) counselling.
- The candidates have to report for counselling and other admission formalities on **15.11.2023 at 9.30 A.M.** in the Veterinary Auditorium, COVS, LUVAS, Hisar and shall have to pay fees and other charges there and then, otherwise the seat will be declared vacant. The candidates reporting late may lose their right of admission.

- v. The candidates who had not applied for admission by filling application form of LUVAS but participated in NEET (UG)-2023 examination and obtained NEET score, may be allowed to participate in the Mop-Up (Physical) counselling scheduled to be held on 15.11.2023 by paying a fee of Rs.14000/- on the day of counselling.
- vi. Any candidate who has taken admission in COVS, LUVAS, Hisar or any affiliated private colleges will not be allowed in Mop-Up Counselling. However, if he/she wants to cancel his/her admission, he/she has to submit a request in the o/o Registrar, LUVAS, Hisar, atleast 2 working days prior to Mop-Up (Physical) counselling, failing which he/she will not be allowed to participate in Mop-Up (Physical) counselling.
- vii. The candidates are required to bring all the original documents, two recently taken photos and two sets of self-attested photocopies of documents etc. as per rule 3.11 of chapter-IV of the Prospectus, at the time of document checking, failing which they shall be refused admission.
- viii. Once, a candidate is allotted a seat in a college and the candidate fails to deposit the fee and complete other admission formalities, he/she will be debarred for admission.
- ix. The candidates may deposit the fees in the form of Demand Draft in favour of "Dean, College of Veterinary Sciences, LUVAS, Hisar" payable at any scheduled bank at Hisar or through RTGS/NEFT and the proof of deposition of fees is to be submitted in the o/o Dean, COVS on 15.11.2023.
