Mr Bawar Khan Safi s/o Mr Sayad Ali Khan, resident of Afghanistan has been admitted provisionally to Master of Veterinary Science as per his merit and choice during 1st counseling for 1st Semester of Academic Year 2019-20, on the recommendation of ICAR under India-Afghanistan Fellowship Programme in the Livestock Production Management (LPM) discipline. The candidate had deposited the token money of Rs 1120/- instead of full fee & hostel charges and has obtained medical certificate of fitness from the Civil Hospital, Hisar. He is required to get himself registered on 8th August, 2019, failing which his admission will be cancelled and no further extension will be granted. The candidate has shown the original documents.


