The following person(s) is/are hereby appointed to the temporary post of Computer Operator against the vacant post in the Pay scale of Rs. 5200-20200+1900 GP in PB-1 (Revised to Level/FPL-2 in pay matrix of Rs.19900-63200) at a starting minimum salary of Rs.19900/- per month plus other allowances as admissible according to the rules of the LUVAS, Hisar as applicable from time to time, w.e.f. the date he reports himself for duty:

He shall be:

- on probation for a period of two years which can be extended or reduced by the competent authority. In case his work or conduct is not found to be satisfactory at any time during the period of probation, his services may be dispensed with/without any notice.
- required to produce Medical Certificate of fitness from the Senior Medical Officer, CCSHAU, Hisar before he is allowed to join.
- required to pass departmental examination and such other tests as are/may be prescribed by the Vice-Chancellor from time to time.
- liable to transfer to any other post/work, without affecting his emoluments adversely, at any time as and when it is considered necessary by the competent authority. It will also be open to the University to depute him to work elsewhere for specific period.
- required to produce before joining, relieving certificate from his present employer, if any.
- entitled to leave, T.A. and other allowances etc. according to the provisions of the Act & Statutes/TA Rules of this university and orders/instructions as are in force or amended/issued from time to time.
- governed by other conditions of service in accordance with the Statutes of this University and such other rules and order/instructions as are in force or may be amended/ introduced from time to time.

- h) liable to removal from service and such other action as may be deemed necessary, if any declaration given or information furnished by him is false/forged or if he is found to have willfully suppressed any information in the application form.
- i) his character and antecedents have not been got verified and are required to be got verified within a period of 3 months from the date of joining. In case subsequently any adverse facts come to the notice of the University, his service is liable to be terminated.
- j) governed by New Defined Contributory Pension Scheme amended/issued from time to time.
- k) liable to report himself for duty in the office of Dean, CODST within four weeks from the date of issue of these orders failing which it will be presumed that the offer is not acceptable to him and the same is likely to be withdrawn.
- l) shall have to qualify the State Eligibility Test in Computer Appreciation and Application within the period of Probation of two years extended by one year failing which his service will be dispensed with. He shall not be entitled to any increment in his pay scale till he qualify the said test.
- m) at the time of joining, he is required to submit an affidavit on non-judicial stamp paper worth Rs.10/- duly attested by 1st Class Magistrate to the effect that he has not been dismissed from any Govt./Semi Govt. service, has not been punished on an act of moral turpitude and has not been involved in any disciplinary/ vigilance case.

2. His appointment is in anticipation of verification of his Caste/Degree/Diploma Certificate/benefits under socio-economic criteria from the concerned authorities with the condition that his services can be dispensed with, without any notice in case his certificate(s) is/are found false/forged.
