I am directed to inform you that the Vice-Chancellor has approved the following amendment under Clause 2(2) of Chapter VI of the Statutes with immediate effect subject to confirmation by the Board of Management.

Existing provision under Clause 2(2) of Chapter VI

All employees of the University shall retire from its service on attaining the age of 60 years provided that nothing in this clause shall apply to any technical or scientific personnel appointed for a specific period under contract and provided further that the Vice-Chancellor may re-employ employee upto the age of 63 years. Even after that date, the University may engage such persons on contract basis at the most for a period of two years. Person above 65 years if engaged through any source, will be subjected to Board's approval. The age of retirement in respect of Vice-Chancellor will be as prescribed.

Amended provision under Clause 2(2) of Chapter VI

All employees of the University shall retire from its service on attaining the age of 60 years provided that nothing in this clause shall apply to any technical or scientific personnel appointed for a specific period under contract and provided further that the Vice-Chancellor may re-employ any employee* upto the age of 63 years. Even after that date, the University may **re-employ** such persons on contract basis at the most for a period of two years. The age of retirement in respect of Vice-Chancellor will be as prescribed.
