Since there is no course from clinical department in B.V.Sc.&A.H. 3rd Year, so evaluation of 3rd Year VCC course should be done on the basis of routine clinical examination like recording of clinical parameters, recording of case history, routine laboratory examination and precautions to be followed while working in various units of Veterinary Clinical Complex including Clinical Laboratory as decided by instructors from different sections.
