During the course of meeting, the Hon'ble Chief Secretary, Government of Haryana pointed out that Haryana poultry farmers are facing problems in raising poultry. To solve these, it was advised that in order to maintain liaison between the poultry farmers and concerned officials/scientists, a "WhatsApp" group of Animal Husbandry Department officials, Veterinary Surgeons, University Scientists and poultry farmers of the State may be created immediately by the Animal Husbandry & Dairying Department, Haryana. It was informed that LUVAS has already created a helpline number (9300000857) which caters to the need of farmers and provides advice/services regarding animal health management, feeding, telemedicine, preliminary treatment of animals, poultry etc. by the expert scientists of the university. The services of expert scientists are also being made available to the farmers during trainings, animal health camps being organized from time to time at various Haryana Pashu Vigyan Kendras of LUVAS.

The Board was apprised that Higher Education, Department, Govt. of Haryana has decided to start Under Graduate courses leading to award degree in Animal Husbandry. It was decided that the University authorities may take up the matter with the Director, Higher Education through Administrative Department intimating the mandate of the University as per Lala Lajpat Rai University of Veterinary and Animal Sciences Act notified by the Haryana Govt., Law and Legislative Department, Haryana Act No. 7 of 2010. The institution desirous to award degree in Animal Husbandry will be required to fulfill Veterinary Council of India norms and also to seek affiliation from Lala Lajpat Rai University of Veterinary and Animal Sciences.
