The following items were discussed and decision taken thereof:-

Agenda Item No. 18A-1:

Confirmation of the Proceedings of the 17<sup>th</sup> meeting held on 21.10.2013.

The proceedings as circulated vide No. 6714-27 dated 23.10.2013 were confirmed.

Agenda Item No. 18A-2:

Action taken report on the Proceedings of the 17<sup>th</sup> meeting of the Academic Council held on 21.10.2013.

Noted.

Agenda Item No. 18A-3:

Revision of academic calendar of BVSc & AH programme for the year 2013-14.

Approved as proposed.

Agenda Item No. 18A-4:

Conduct of Internal Examinations (Undergraduate).

Approved as proposed with the modification that the words atleast 2-3 days in advance may be read as within 3 days prior to the examination under proposed rule 11.2.

Agenda Item No. 18A-5:

Maintenance of record of Entrance Test (s) UG & PG Examinations.

Approved as proposed. It was further decided to mention the provision in the prospectus and to display it on the University Website.

Agenda Item No. 18A-6:

Compulsory participation in sports and cultural activities starting from the year 2012-13.

The issue was discussed in detail and the following decisions were taken.

- (i) The grades of sports and cultural activities received/to be received as Satisfactory or Unsatisfactory for the Academic year 2012-13 & 2013-14 respectively may be accepted.
- (ii) From the next academic year i.e. 2014-15 the issue will be examined in totality by a committee to be approved by the Vice-Chancellor. The Committee will submit its report latest by 31.12.2013.

Agenda Item No. 18A-7:

Permission for Ph.D. admission of in-service candidates in LUVAS, Hisar.

The Council approved granting of permission to in-service teachers of LUVAS for taking admission in Ph.D. programme in the University. However such in-service teachers should not register more

than 12 credits of courses in a semester and will contribute towards Teaching/Research/Extension activities to the tune of 1/3 of teaching load assigned to an Assistant Professor.

Agenda Item No. 18A-8:

Establishment of College of Diary Science and Technology.

The proposal was approved. However, it was felt by the Council that there is a need to incorporate courses of Dairy Husbandry. Designated Dean was requested to incorporate these courses by 16.11.2013.

Agenda Item No. 18A-9:

Selection criteria for the posts of Assistant Professor/equivalent, Associate Professor/Equivalent and Professor/equivalent.

The action taken by the Vice-Chancellor was confirmed. It was further recommended to place the matter before the BOM for ratification.

Agenda Item No. 18A-10:

Implementation of Career Advancement Scheme for teachers of LUVAS, Hisar.
