Agenda Item No. 25A-5:

CMP No. 10211 of 2014 in CWP No. 23721 of 2013 filed by Jan Shakti Charitable Trust, Rohtak on behalf of International Institute of Veterinary Education and Research (IIVER, Bahu Akbarpur, Rohtak against Union of India & Ors in High Court of Punjab & Haryana – compliance of judgement-admission-regarding 2014-15.

The agenda item was considered along with supplementary note. Two requests of Dr. Anil Pannikker dated 16.11.2014 and the other of Dr. Ramkaran and others dated 04.11.2014 were also circulated to the members with the supplementary note and the council, after considering all the facts of the case, took the following decisions:

- 1. No. of seats to be filled up: 60 (sixty)
- 2. (i) Admission schedule:

- (a) 1st Counselling: 26.11.2014 at 10.00 A.M (50% seats will be filled by the University out of the candidates who have qualified the entrance test (2014-15) of the University for B.V.Sc.&A.H. programme. 50% of management quota seats will be filled up on the basis of the merit of the entrance test to be conducted by IIVER, Bahu Akbarpur, Rohtak).
- (b) 2nd Counselling:29.11.2014 at 10.00 A.M.
- (ii) Process of Counselling: All the 60 seats (State quota and Management quota seats) will be filled up at LUVAS Campus.
- (iii) Venue: Seminar Hall, deptt. of VAHEE, COVS.
- 3. Fee Structure: The prospective candidates may be apprised that fee structure as approved by the Govt. will be applicable. However, University will charge registration fee of Rs.6000/- and examination fee of Rs.1700/- per student in addition to other fee structure at the time of counselling.
- 4. Since the institute/trust has already deposited bank guarantee/security with the VCI, it was felt that bank guarantee at this stage is not required. However, administrative expenses may be realized from the institute before admission.
