- (iv) Six years of experience of teaching/ research or extension in an academic/ research position equivalent to that of Assistant Professor in a University, recognized College or accredited Institution excluding the period spent for Ph.D degree.
- (iv) **Eight** years of experience of teaching/ research or extension in an academic/ research position equivalent to that of Assistant Professor in a University, recognized College or accredited Institution excluding the period spent for Ph.D degree.

It is also brought to your kind notice that as per letter received from Additional Chief Secretary to Govt. of Haryana, Animal Husbandry & Dairying vide memo no. 12058(CFMS) AH-4-2018/21742 dated 29/11/2018 duly adopted by LUVAS vide Notification No LUVAS/CVU/B-1/2018/5388 dated 03/12/2018, University (LUVAS) shall accept all the conditions as well regulations of UGC. Further, according to UGC Gazette Notification dated 18/07/2018 minimum experience for the post of teaching and/or research in an academic/research position equivalent to that of Assistant professor in a University, college or accredited research institution/industry will be eight years.

Therefore, keeping in view of the above before placing in the meeting of Academic Council, the matter is placed before the Board of Studies for consideration/further necessary action accordingly please.
