Subject: Grant of 2nd mercy chance to the failed students of VLD diploma course.

A meeting was held under the chairmanship of Worthy Vice-Chancellor in the O/o Vice-Chancellor Secretariat to grant one more mercy chance to the failed VLDD students for the session 2020-21.

All the possibilities regarding moderation of result keeping in view of Covid-19 pandemic condition, online classes, non-availability/interrupted facilities in the rural areas, etc. were discussed. On the recommendation of the Committee, it has been ordered by the Worthy Vice-Chancellor, LUVAS that one more mercy chance be granted to the failed VLDD students and their examinations be conducted offline in the respective (failed) subject(s). A preparatory time of approximately fifteen days is given to all the 1st and 2nd year failed students of VLDD before commencement of the examinations.

The capping of examination fees for these examinations will not exceed more than rupees 2000/- (Two thousand only) as one-time measure and supplementary examination fee will be as per Rules & Regulations of Governing Diploma Courses. No precedence will be taken of this relaxation in future.

Other modalities will be detailed out by the Director, IPVS in consultation with COE, LUVAS, Hisar as per the existing rules of the University.

In compliance, the Director, IPVS issued an order vide memo no. IPVS/2022/896-899 dated 06.06.2022. (Copy attached)

In view of above, the matter is placed before the Board of Studies for ratifying the action taken by Worthy Vice-Chancellor, LUVAS.

The Committee in its meeting held on 13.05.2022 at 9.00 am in the O/o the Chairman deliberated on the issue and following were the observations:

- 1. As per the available information, the students of similar stream in other universities (MAFSU, Nagpur; WBASU, Kolkata) receive stipend of Rs. 3000/- (Rs. 2500 as ICAR share and Rs. 500/- as State share) per month for the Student Ready in Plant Training Plan for one semester. The ICAR generally provides the funds only after accreditation of the college which has not been done for the college at LUVAS. Hisai.
- 2. The Committee came to know that the students of GADVASU, Ludhiana receive a sum of Rs. 6000 - for similar training program provided by Verka. Punjab which may be due to some official agreement or MOU etc.
- 3. The Committee is of the opinion that an official MOU may be signed with Vita or other dairy industries of Haryana where the students can undergo their training program and get the financial assistance in form of stipend from the same industry.
- 4. The students of the programme may also be allowed to take personal initiatives to arrange their training programmes in different dairy industries of Haryana identified by LUVAS.
- At present, the students are getting a financial assistance of Rs. 11000/- by LF \(\chi\) \(\chi\). Hisar in the form of exemption of tuition fee for the 7th semester of their degree programme vide approved by the Academic Council in its 48th meeting held on 03.09.2019.
