Payment of Dearness Allowance to Haryana Government employees, who are drawing their pay as per 7th Pay Structure w.e.f. 1st January, 2022.

The Governor of Haryana is pleased to decide that the Dearness Allowance payable to Haryana Government employees, who are drawing their pay as per 7th Pay Structure, shall be enhanced from the existing rate of 31% to 34% of the basic pay with effect from 1st January, 2022. Enhanced DA shall be payable with the pay of April, 2022 and arrear for the months of January, 2022 to March, 2022 shall be payable in the month of May, 2022.

The payment on account of Dearness Allowance involving fractions of 50 paise and above may be rounded to the next higher rupee and the fractions of less than 50 paise may be ignored.
