Grant of Interest free advance to Government employees for the purchase of wheat during the year 2019-20

In continuation of this office memo no. LUVAS/CVU/B-1/2019/1404-45 Dated 10.05.2019, the Vice-Chancellor, LUVAS, Hisar is pleased to extend the period to avail the benefit of Interest free advance of Rs.18000/-(Eighteen Thousand Only) for the purchase of wheat for University Class-IV employees up to 30.06.2019 on the pattern of State Govt

- The advance will be admissible to permanent/temporary regular employees only. The advance will be sanctioned by the Drawing & Disbursing Officer concerned who would, in the case of temporary employees, allow advance on the basis of a surety to their satisfaction so that it is fully secured and its recovery is ensured from the loanee before the close of the financial year 2019-20.
 - 3. The following conditions should be observed in sanctioning this loan: -
 - i. A certificate may be obtained within one month of the drawl of the advance from the loanee to the **effect that he** has utilized the loan for the purchase of wheat.
 - ii. The Officer concerned, before sanctioning the advance, should satisfy himself that the incumbent will continue in service until full recovery of the total amount of the advance is affected.
 - iii. These orders will cease to operate after 30th June, 2019.
 - iv. The recovery of the first instalment of the advance should preferably be made from the pay for the month of July paid in August, 2019.
 - v. The advance should not be granted to those employees who are on deputation to other Govt./Corporations and Local Bodies etc.
 - vi. The advance will not be admissible to work charged, contractual and daily wages employees.
 - vii. Where both husband and wife are employed, the wheat advance should be allowed to only one of them.
- The entries of wheat loan of Rs.18000/- are to be recorded in ECR and Demand & Collection Register and for disbursement as well as recovery of wheat loan, D&DO will be personally responsible.
