Subject:- Clarification on grant of ACPL on passing the departmental test.

I am directed to draw your kind attention towards Rule-8 of HCS (ACP) Rules, 2016, whereby, a specific provision is prescribed for availing the benefit of 1st, 2nd and 3rd ACP Level that after completing the respective prescribed period, an Government employee should be fit to be promoted to the immediate next higher post only in the functional hierarchy in his cadre, but despite of fitness he could not be functionally promoted due to lack of vacancy. Further, if such promotion involved passing of any departmental or other test, such condition should also be fulfilled by the Government employee.

Now, few cases have been received in the Finance Department with the query as to in case, the Government Employee has passed departmental test after completing the period of eight years of service, when will S/he be entitled for 1st or 2nd or 3rd ACPL after passing the departmental test as per ibid rules.

The matter has been examined in the Finance Department and it is clarified that, in such type of cases, the matter shall be considered for 1st or 2nd or 3rd ACPL as the case may be, from the date of passing such examination/test, subject to fulfilment of other terms and conditions as laid down in ACP rules. Further, there will be no cumulative effect on subsequent ACPs. A few illustrations indicating the manner in which the cases of ACPs are to be considered, are given below:-

Example-I:

Mr. A joined service as Jr. Scale Stenographer in the pay scale of Rs.5200-20200+2400GP (FPL-4) on 5th March, 2006 and there is a provision of departmental test in Service Rules for promotion to the next post i.e Senior Scale Stenographer and he has qualified the requisite departmental test on 10th November, 2016. As such Mr. A shall be considered for 1st ACPL-6 corresponding to FPL-4 u/r 7 of HCS (ACP) Rules, 2016 w.e.f. the date of passing of the departmental test i.e 10th November, 2016 and his pay would be fixed as per Rule 21 of HCS (ACP) Rules, 2016. Further, his case for 2nd and 3nd ACPL shall be considered on 1st April, 2022 and 1st April, 2030 respectively subject to fulfilment of other terms and conditions as laid down in ACP rules.

Example-II:

Mr. B joined service as Jr. Scale Stenographer in the pay scale of Rs.5200-20200+2400GP (FPL-4) on 5th March, 2006 and there is a provision of departmental test in Service Rules for promotion to the next post i.e Senior Scale Stenographer and he has qualified the requisite departmental test on 10th November, 2023. As such Mr. B shall be considered for 2nd ACPL-7 corresponding to FPL-4 u/r 7 of HCS (ACP) Rules, 2016 w.e.f. the date of passing of the departmental test i.e 10th November, 2023 and his pay would be fixed directly in 2nd ACPL, as per Rule 21 of HCS (ACP) Rules, 2016. Further, his case for 3rd ACPL

shall be considered on 1st April, 2030 subject to fulfilment of other terms and conditions as laid down in ACP rules.
