Subject:- Clarification regarding Composite Transfer Grant.

I am directed to draw your attention towards Finance Department's orders No.5/27/98-1FR(FD) dated 20.06.2018 whereby Note-3 below point 'J' under Annexure provides that, "the admissible entitlement, subject to all other conditioned governing it, shall be increased by 5% every year, with first such increase taking place after this order comes in force on 01.01.2019", whereas, Note 2 below Rule 54 of HCS (TA) Rules, 2016 prvides that, "the rate of composite transfer grant shall automatically stand increased @5% from 1st April every year".

However, it has come to the notice to the Finance Department that these orders are being wrongly interpreted/followed by the Departments and composite transfer grant is being allowed by increasing @5% from 1<sup>st</sup> January of every year after issue of Finance Department orders dated 20.06.2018 whereas composite transfer grant is to be increased automatically @5% from 1<sup>st</sup> April every year as per rules ibid.

Therefore, it is calrified that, the rules shall prevail and the rate of composite transfer grant had to be and shall be increased @5% from 1<sup>st</sup> April every year. Recovery should be made in cases which have already been decided /settled for the period from 01.01.2019 to till date, in case increase was allowed from 1<sup>st</sup> January.
