Further, RIC recommended:

- i) To place the matter before the Worthy Vice-Chancellor for seeking approval to send the details of intake capacity of PG programmes to the ICAR for the academic year 2024-25.
- ii) To send the detail of PG seats to the Prospectus Committee for incorporation in the LUVAS Prospectus for the academic year 2024-25.

Agenda Item No.62 RIC-4:

Creation of additional seats for admission to M.V.Sc., M.Tech. and Ph.D. programmes for wards of LUVAS employees w.e.f. the academic year 2024-25.

A representation was submitted by the LUVASTA on 16.11.2023 for creation of additional seats in UG and PG programs for the wards of LUVAS employees and same has been forwarded by the office of registrar for placing the matter before the RIC.

LUVASTA in its representation requested to create the seats for PG programme in following manner:









- 1. Two additional seats for Master's programme per college.
- 2. One additional seat for Ph.D. programme per college.

In view of the above, it is pertinent to mention here that one seat each in the B.Tech. and B.V.Sc.& A.H. programme has already been earmarked for the wards of regular employees of the LUVAS as per following conditions mentioned in LUVAS Prospectus 2023-24:

- For B.V.Sc. Programme: One seat for the wards of regular employees of i) LUVAS (preferably to ward of deceased employee, who dies in-service) against the seat, if remains vacant under NRI /J&K Residents / Kashmiri Migrants category.
- For B.Tech. Programme: One seat in B.Tech. (Dairy Technology) ii) programme is earmarked for the wards of regular employees of LUVAS (preferable to the ward of deceased employee who dies in-service), against the seat, if remains vacant under J&K residents / Kashmiri Migrants / non migrant Kashmiri Pandits / Kashmiri Hindu Families category.

The RIC discussed the matter at length and unanimously recommended for sending the matter to the Prospectus Committee for the year 2024-25 for consideration and taking a decision in the matter.

The meeting ended with a vote of thanks to the Chair.
