Agenda Item No.64 RIC-3: Reconsideration of case regarding creation of

additional seats for admission to M.V.Sc., M.Tech. and Ph.D. programmes for wards of

LUVAS employees

The matter of creation of additional seats for the wards of LUVAS employees was discussed at length in 62th meeting of RIC held on 27.12.2023 vide Agenda Item No. 62 RIC-4 and RIC unanimously recommended for sending the matter to the Prospectus Committee for the year 2024-25 for consideration and taking a decision in the matter. The prospectus committee during the meeting held on 04.05.2024 suggested that the matter should be got approved from RIC and Academic Council before including in the Prospectus.

The matter was also placed by the Registrar, LUVAS for additional seats in UG and PG programmes for wards of LUVAS employees in 321st meeting of Board of Studies (BOS) held on 03.05.2024 and the agenda related to creation of additional seats in PG programmes was not discussed in the meeting.

In view of the above, the matter of creation of additional seats for admission to M.V.Sc., M.Tech. and Ph.D. Programmes was placed before the RIC for reconsideration and decision.

The RIC discussed the matter at length and unanimously decided for creation of one supernumerary seat each in M.Tech. Programme of college of Dairy Science and Technology, and M.V.Sc. Programme of College of Veterinary Science for the wards of regular employees of LUVAS (preferably to the ward of deceased employee who dies in service). The seat will be filled by the procedure laid down for other supernumerary seats in the Prospectus of the respective year.

Further, all RIC members were of view that the wards of regular employees of LUVAS who get admission against seat earmarked for the wards of regular employees for admission to B.V.Sc. & AH and B.Tech., their candidature should not be considered for admission to M.V.Sc. and M.Tech. programmes against supernumerary seat for the wards of regular LUVAS employees. Further, RIC unanimously decided that there should not be any supernumerary seat in Ph.D. programme of the University for the wards of LUVAS employees.

In view of the above, the RIC recommended to place the matter before the worthy Vice-Chancellor for seeking approval to place the same before the ensuing meeting of Academic Council for consideration and decision, please.

The meeting ended with a vote of thanks to the Chair.
