Subject:- Regarding pay protection of teaching faculty in the Universities who have subsequently appointed from State Pay Structure with in the Haryana.

I am directed to invite your kind attention towards subject cited above. The matter regarding pay protection was under consideration in the Finance Department on subsequent appointment of teaching faculty in the UGC/AICTE Pay Structure of the Universities/Colleges of the State of Haryana, who had rendered his/her previous service in the State Pay Structure in any Department of Haryana.

2. After careful consideration at length, it has been decided by the State Government to protect the pay of such employees who have been subsequently appointed from State Pay Structure to UGC/AICTE pay

structure in any University/College, in the following manner:-

"On subsequent appointment to a teaching post from any department of Haryana to any university/college or in the same university/college or other university/college (within state), from State Pay structure to UGC/AICTE pay structure and where the application for the same has—

(i) not been submitted through proper channel, pay shall be fixed at entry level (first cell) of the post of subsequent appointment admissible; or

been submitted through proper channel, the pay shall be fixed—

(a) at entry level (first cell) of the post; or

(b) equal to the corresponding cell if available in the functional level of the new post; or

(e) at the next cell above the existing cell if the same cell is not available in the functional level of the new post;

as the case may be.

Note 1.— Where pay is fixed equal to entry level pay, the date of next increment in the cases (i) and (ii) (a) above shall be the 1st January or 1st July subject to completion of more than six months qualifying service from the date of subsequent appointment.

Note 2.— Where pay in the pay level is fixed equal to the pay already drawn, the date of next increment in (ii) (b) above shall remain unchanged.

Note 3.-Where the pay is fixed under (ii) (c) above, the date of next increment shall be the 1st January or 1st July subject to completion of more than six months qualifying service from the date of subsequent appointment.

Note 3.- The past service shall not be counted towards any other benefits like CAS etc.
