Subject:-

Payment of revised Dearness Allowance and Dearness Relief to the Haryana Government employees & pensioners/family pensioners, who are drawing their pay & pension/family pension as per 7th Pay/Pension Commission Structure, w.e.f. 1st January, 2025.

The Governor of Haryana is pleased to enhance the Dearness Allowance (DA) and Dearness Relief (DR) payable to Haryana Government employees & pensioners/family pensioners from 53% to 55% of the basic pay & pension/family pension with effect from 1st January, 2025.

- 2. Enhanced DA & DR shall be paid with the pay & pension/family pension of April, 2025 and arrear for the months of January, 2025 to March, 2025 shall be paid in the month of May, 2025. The payment on account of Dearness Allowance & Dearness Relief fractions of 50 paise and above may be rounded to the next higher rupee and the fractions of less than 50 paise may be ignored.
