In pursuance of the decision taken by the Academic Council vide Agenda Item No.

71A-16 in its 71st meeting held on 15.05.2025, the following criteria and guidelines have been made for instituting scholarship:

Criteria for instituting scholarship

- 1. The scholarship program can be established by various entities, including individuals, alumni, Foundations, people in business or by groups of individuals.
- 2. An amount of Rupees Six lakhs will be required to be deposited for this purpose in university account and the interest accrued on the principal amount will be utilized to disburse scholarship to deserving students. The following table illustrates how the interest amount will be utilized:

Amount deposited by the contributor (Rs)	Number of scholarships to be instituted	Beneficiary of the scholarships
6,00,000.00	One	Student from only one Professional year
12,00,000.00	Two	One student from one Professional year and other student from other Professional year Or
18,00,000.00	Three	Two students from same Professional year One student each from three different Professional years Or

- The scholarship programme should be proposed by/named after an alumnus of constituent colleges of LUVAS or proposer as the case may be.
- 4. The name of the scholarship should inspire and motivate the students to strive for excellence in their academic pursuits and to honour the values and principles that the teacher/eminent personality represented.
- 5. If the contributor wishes the scholarship to be paid to students of a specific category, the scholarship will be awarded to the students from the category desired.

Eligibility guidelines for the scholarship

- The scholarship will be paid on the basis of merit to the student (irrespective of income of the family) who obtains the highest overall grade point average obtained during the year prior to the year when the scholarship has to be awarded.
- 2. A student availing this scholarship will not be entitled to avail any other scholarship from the University during the duration of scholarship. If the student

wants to avail this scholarship, he/she will be required to give up the claim of any other scholarship awarded by the University.

- 3. An amount of Rs.25000/- as scholarship will be awarded to each recipient. This amount can be revised from time to time.
- 4. The scholarship will be awarded to students of constituent colleges only.
- 5. A particular scholarship will be meant only for excellence for a specific professional year after its completion as per choice of the sponsor.
- If it is observed that two or more students have obtained the same percentage of marks/OGPA, the student with the lower family annual income will be given option of availing this scholarship or the other scholarships offered by the University.
- 7. Before finalizing the scholarship award, the constituted Committee will announce the selected awardee's name and will invite objections from other eligible candidates in order to ensure transparency and fairness in selecting the scholarship recipient.
- 8. To remain eligible for the scholarship, the student must have obtained an overall grade point average (OGPA) of **6.5** out of 10.00 basis.
- 9. A student who has been placed on scholastic/conduct probation or had been either rusticated or expelled from the University or who has awarded 'F' grade in any of the courses during the academic programme, shall not be eligible for the award of scholarship. However, the "Unsatisfactory" grade obtained in case of deficiency of /or non-credit courses shall not debar the students for the scholarship award in case otherwise eligible.
- 10. The scholarship is subject to the condition that the recipient will pursue his/her studies with diligence and abide by the disciplinary and other rules of the university/college/hostel. If he/she is found guilty of indiscipline or misconduct, he/she will not be eligible for the award of scholarship.
- 11. The particulars of the scholarship recipients, including their names and academic performance, shall be forwarded to the donor(s), if any.
- 12. The award of scholarship does not exempt the recipient from paying tuition and other fees to the university/college/ hostel etc.

13. In case of any dispute or difference of opinion, the decision of the Vice-Chancellor shall be final.
