Subject: Reservation in promotion to Persons with Benchmark Disabilities (PwBDs).

Sir/Madam,

I am directed to invite your attention to the subject cited above and to say that Government of India, DoPT vide their O.M. 36012/1/2020-Estt. (Res.-III) dated 17.05.2022 has provided that the promotion to the employees of benchmark disabilities in the cadre strength within Group 'C', from Group 'C' to Group 'B', within Group 'B' and from Group 'B' to the lowest rung of Group 'A' shall be reserved for PwBDs.

- 2. This matter has been examined by State Government and after careful consideration, it has been decided that there should be uniformity in Centre and State policy. Therefore, in line with the Govt. of India, it has been decided to grant reservation in promotion with prospective effect from Group-D to 'C', within 'C' & 'C' to 'B', within 'B' and 'B' to the lowest rung of Group-A and no reservation in promotion from Group-A to Group-A shall be admissible. Other provisions of the instructions dated 11.07.2023 shall remain unchanged.
- 3. It is also reiterated that the benefit of reservation in promotion is without consequential seniority and for promotion on the basis of seniority-cum-merit, the seniority of all the disabled persons will be fixed separately by each Department in their respective cadre.
- 4. These instructions may please be brought to the notice of all concerned for compliance in letter and spirit.
