The 361st meeting of Board of Studies, COVS, LUVAS was held on 19.05.2026 in the Committee Room of Dean COVS at 7.30 A.M. The Chairman, BOS-cum-Dean COVS, LUVAS welcomed the members present in the meeting. Following decisions were taken in the meeting:

Agenda Item No. 1. Confirmation of proceedings of 360th meeting of BOS held on 02.05.2026 at 1.00 P.M.

Proceedings of 360th meeting of BOS circulated vide letter No. VPP/BOS/2026/838-862 Dated 02.05.2026, were confirmed.

Agenda Item No. 2. Regarding revision of remuneration for Educational Tour of the B.V.Sc & A.H. students.

An agenda item regarding revision of remuneration for Educational Tour of the B.V.Sc & A.H. students was received from O/o Dean COVS, LUVAS, Hisar for discussion by the house. After discussion, the following agenda regarding revision of remuneration for Educational Tour of the B.V.Sc & A.H. students was recommended by the house for further approval from the Academic Council, LUVAS, Hisar:

Agenda Item No. 3. Regarding renewal of temporary annual affiliation of affiliated private colleges/institutes to run VLDD programme for the academic session 2026-27.

An agenda item regarding renewal of temporary annual affiliation of affiliated private colleges/institutes to run VLDD programme for the academic session 2026-27 was received from O/o Director IPVS, LUVAS, Hisar for discussion by the house. After discussion, the house approved the agenda as follows for further submission to the affiliation committee:

1. The IIVER, Bahu Akbarpur, Rohtak has come under the Schedule-I of VCI Act, 1984, and as stated in rule no. 4 (i) of Norms, Procedure and Guidelines of Diploma Courses "for college which come under the Schedule- I of VCI Act, 1984, the inspection shall lay off, unless warranted". So, the inspection of said college is lay off.
2. Moreover, SBDS College Veterinary and Animal Sciences, VPO Aherwan, Tehsil Ratia, Distt. Fatehabad got affiliation in the year 2018 and the first batch of said college was passed out in 2020. The college has completed five years after passing of first batch in 2025. As stated in Rule no. 4(ii) "for colleges, which do not come under Schedule-I of VCI Act 1984, subsequently to the period of five years after the first batch of VLD diploma students admitted through LUVAS has passed out, inspection will be after every two years, chargeable as per existing rules". In light of the above, the inspection of said college is lay off for the session 2026-27 as the inspection of college was conducted for the academic session 2025-26 and the inspection will be due in the session 2027-28.
3. The house agreed to grant temporary affiliation to the following colleges/institutes to run VLDD programme for the session 2026-2027 as per rule no. 3 of the latest Norms, Procedure and Guidelines of Diploma Courses.

 - ii) **Balaji College of Veterinary Science & Research Center, 8 km Stone Bhiwani-Loharu Road, Kusumbhi Mor, Near Village Devsar, Teh. & Distt. Bhiwani**
 - iii) **Rohitash Veterinary College, NH-11 Bypass, Ateli Mandi, Distt. Mahendergarh**
4. The house agreed to grant temporary affiliation to the following colleges/institutes to run VLDD programme for the session 2026-2027 as per rule no. 3 of the latest Norms, Procedure and Guidelines of Diploma Courses. However, it was resolved that an affidavit may be obtained from the colleges/institutes regarding fulfillment of deficiencies (as pointed out by the inspection committee in their report) and a compliance report will have to be submitted by the college/institute regarding fulfillment of deficiencies, one month prior to the start of Academic Session 2026-2027 which may be examined by the respective inspection committees, if required.


Agenda Item No. 4. Regarding Amendment in Rule No. 6.2 of Chapter-I of Rules and Regulations Governing Diploma courses.




