Agenda Item No. 68A-1** in its 68th meeting held on 28.05.2024, the Worthy Vice-Chancellor is pleased to make following amendments pertaining to Examination and evaluation rules in Chapter-II of University Calendar Vol.-II.

(iii) The complete details of Annual Practical Examinations should be maintained in the tabulated form showing the marks obtained by the students under different heads like experiment /viva-voce /quiz / practical note book / written component, etc. and the same is to be submitted to the office of COE, LUVAS, Hisar along-with the attendance and result within a week of the completion of all the practical examinations of that professional year. The detailed record of the quiz, spottings, experiment, etc. (as mentioned above) of all the students is also to be submitted to the office of COE.

(iii) The complete details of Annual Practical Examinations should be maintained in the tabulated form showing the marks obtained by the students under different heads like experiment /viva-voce /quiz / practical note book / written component, etc. and the same is to be submitted to the office of COE, LUVAS, Hisar along-with the attendance and result within a week of the completion of all the practical examinations of that professional year. The detailed record of the quiz, spottings, experiment, etc. (as mentioned above) of all the students is also to be submitted to the office of COE.

(iv) The results of Internal Assessments and Practical Examinations for various courses of B.V.Sc.&A.H. shall also be entered in the E-governance system by the respective teachers of COVS and affiliated colleges. Upon entry of these results, the concerned teacher shall take a print out, put signatures and then submit the results through respective HODs/ Dean to COE office, LUVAS for preparation of Final results.
